If you are working with an established publisher we will purchase your book directly from that publisher. You can notify us of the availability of your book by emailing [info@fabledbookshop.com](mailto:info@fabledbookshop.com).

For authors who are self-published or otherwise unavailable through established publishing channels, please refer to the following guidelines we have created for consignment titles:

Author(s) must live in Texas.

Books must be professionally bound with the title printed on the spine.

Books must be found to be of acceptable quality re: writing, editing, design, etc.

The story/content must be deemed in line with Fabled's brand & community interests.

To offer your work for consideration, please deliver a copy of the book to Fabled in a large envelope marked "ATTN: Consignments." Include the Author Contact Form below. We will review the book and respond via email. Due to the number of submissions, the consignment process can take several weeks. All books sent for consideration are non-returnable.

If we decide to carry your book on a consignment basis, you will need to fill out a Consignment Policy Form and submit a \$25 check for handling fees. We will then stock a **maximum of three** copies of your book for **90 days**.

Fabled will pay you 60% of the list price for the quantity of books sold at the end of 90 days. During this period, Fabled may contact you to request additional copies of your work.

Books with no sales history after 90 days will be pulled from Fabled's shelves. At that time, it will become your responsibility to pick up any remaining copies. If they are picked up within 30 days Fabled will donate or dispose of the books.

We are proud to partner with and support local authors. We do our best to provide shelf space for consignment books, while still keeping in mind our own inventory needs. we look forward to reviewing your work, and thank you for your interest in Fabled!

**Policy and Receipt for Books on Consignment**

- The basic handling fee for consignment books is \$25, to be paid by check to Fabled Bookshop & Café.
- Fabled agrees to pay the owner 60% of the list price for the quantity of books sold.
- Fabled may keep consignment books on the shelves for 90 days. At the end of 90 days a check can be made for the amount owed based on the number of books sold according to our Point of Sale system.
- During the 90 day period, Fabled may contact the consigner to request additional copies of the book.
- Books without a sales history after 90 days will be pulled from the shelves. At that time, it is the consigner's responsibility to pick up any remaining copies from the store. After making a genuine effort to contact the consigner, Fabled can donate or dispose of any unsold books that have not been picked up after 30 days.
